Introduction

LFC Solutions, Inc. (“**Lacuna**” or “**we**”), respects your privacy and is committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website www.Lacunamentors.com, including any subdomains thereof (this “**Website**”) and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

- on this Website;
- in email, text, and other electronic messages between you and Lacuna; or
- through mobile and desktop applications provided by Lacuna, which provide dedicated non-browser-based interaction between you and Lacuna.

It does not apply to information collected by:

- Lacuna offline or through any other means, including on any other website operated by Lacuna or any third party; or
- any third party, including through any application or content (including advertising) that may link to or be accessible from or through this Website.

Information We Collect About You and How We Collect It

We collect several types of information from and about users of this Website, including information:

- about your internet connection, the equipment you use to access this Website, and usage details.

We collect this information:

- from third parties, such as internet analytics firms or business partners.

Information You Provide to Us

The information we collect on or through this Website may include:

- information you provide when you report a problem with this Website;
- records and copies of your correspondence (including email addresses) if you contact us;
- your responses to surveys that we might ask you to complete;
- details of transactions you carry out through this Website and of the fulfillment of your orders, which may include financial information; and
- your search queries on the Website.

You also may provide information to be published or displayed (hereinafter, “**posted**”) on public areas of this Website, or transmitted to other users of this Website or third parties (collectively, “**User Contributions**”). Your User Contributions are posted on and transmitted to others at your own risk. Although we limit access to certain pages, please be aware that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of other users of this Website with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

Information We Collect Through Automatic Data Collection Technologies

As you navigate through and interact with this Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:
